### FIRST AID

**IN WISCONSIN:** Crops with high zinc requirements that can be treated are: Corn, Onion, Spinach, Snap Beans. Crops with medium zinc requirements are: Barley, Beans, Beets, Canola, Cucumber, Lettuce, Lupine, Potato, Radish, Sorghum-Sudan, Soybean, Tobacco, and Tomatoes.
